#### 32nd IARIW General Conference, Boston, USA, August 5-11, 2012

For the first time in the history of the International Association for Research in Income and Wealth (IARIW), the General Conference is being held in the United States. Preparations for our 32nd IARIW General Conference, which is taking place in Boston August 5-11, are almost complete. With over 320 persons already registered, the conference will set a record for attendance. Thanks to the great work done by the local organizer, the US Bureau of Economic Analysis (BEA), this conference breaks new ground in several ways.

First, the opening plenary session of the conference will be joint with our American counterpart, the Conference on Research in Income and Wealth (CRIW). IARIW delegates can also attend the concurrent sessions of the CRIW conference on measuring economic stability and progress being held in the same hotel, August 6-8. Second, thanks to a generous donation from the Sloan Foundation on Wednesday, August 8th delegates will have the option of attending special sessions on the tradeoff between timeliness and accuracy and on big data and official statistics. The BEA has put together a stellar set of speakers for these two sessions. National accountants will find these sessions particularly useful.

Third, conference delegates will have the opportunity to hear two extremely high-profile economists. At the dinner Monday evening in honour of Robert Summers, Lawrence Summers, currently Charles Elliot University Professor at Harvard University and President Emeritus at Harvard University as well as a former US Treasury Secretary, will speak. At the farewell banquet on Friday evening Ben Bernanke, Chair of the Federal Reserve Board, will address the audience via videofeed.

Conference delegates are reminded that it is the discussants who both present and discuss the papers at IARIW General Conferences. This means that authors of papers do not have to prepare PowerPoint presentations for their papers.

#### **On-line Availability of Conference Papers**

It has long been an IARIW tradition to distribute papers before the conference to allow participants the opportunity to read them before the event. It is believed that this availability improves the quality of the discussion at the conference. The internet now allows us to make papers available before the conference not just to those attending the conference, but to all members, and indeed to the general public.

I am pleased to announce that almost all of the 185 papers for the upcoming 32nd IARIW General Conference to be held in Boston, USA, August 5-11 are now posted at <a href="http://www.iariw.org/c2012.php">http://www.iariw.org/c2012.php</a>

I hope that many conference participants will have an opportunity to read papers of interest before the conference and to relate their comments to the authors at the conference.

It will take place in Rio de Janeiro in September 2013. The second, co-organized with the University of New South Wales in Australia, will be on productivity issues. It will take place in Sydney in late November or early December 2013. The call for papers for both conferences will be issued shortly after the General Conference in August.
