Subject: Update on IARIW Activities

I am writing to update IARIW members on the current activities of the Association.

IARIW-NBS Conference (China)

In partnership with the National Bureau of Statistics of China (NBS), the International Association for Research in Income and Wealth is organizing a major international conference on the theme of experiences and challenges in measuring national income and wealth in transition economies. The objective of the conference is to further our understanding from an empirical perspective of developments in China and other transition economies (e.g. Russia, CIS, Eastern Europe) in the areas of the measurement of growth, productivity and other macroeconomic aggregates, as well as income distribution.

The conference will take place at the Friendship Hotel in Beijing, China September 18-21. The program is now posted on the website http://www.iariw.org/chinaconference.asp

All IARIW members are invited to attend this important event. There is no registration fee. The number of spaces is limited and registration is on a first come basis. Non-IARIW members from outside China must become an IARIW member to register.
