This message is to update you on recent developments related to the Association.

36th IARIW General Conference

The 36th IARIW General Conference hosted by Statistics Norway had been scheduled to take place in Oslo, Norway this past August. Because of the pandemic, it has been rescheduled to August 16-20, 2021, still in Oslo.

The program from the 2020 event will carry over to the 2021 conference. There will be no new call for papers. The one exception is the plenary session on the update of the SNA. Given that the timelines for the SNA update have not been altered by the pandemic, Council felt that it was important for this session to go ahead. A digital session took place on August 26, 2020. New IARIW President

I am pleased to announce that Council has appointed Kevin Fox from the University of New South Wales as President of the Association for the 2020-2022 term, replacing out-going President Marshall Reinsdorf from the International Monetary Fund. Council named Catherine van Rompaey, formerly with Statistics Canada and now with the World Bank, as President-Elect. She will assume the presidency in August 2022.

2022 General Conference

The 37th IARIW General Conference will take place in Luxembourg August 22-26, 2022. The Association thanks the Central Service for Statistics and Economic Studies (STATEC) in Luxembourg for agreeing to host the conference. Because of the one-year delay with the holding of the 36th General Conference, the timelines for the organization of the 37th General Conference have been compressed from two years to one years. The call for papers for the conference will be out in September 2021.

Special IARIW-ESCoE Conference on Intangible Assets

The IARIW, in partnership with the UK Economics Statistics Centre of Excellence (ESCoE), is hosting a conference on the measurement of intangible investments and their implications for growth and productivity at King's College London, June 24-25, 2021. The main aim of the conference is to bring together academics, statisticians, policymakers and other data users interested in the measurement of intangibles to take forward an agenda for understanding the importance of these rapidly growing investments. The <u>call for papers for the conference</u> is posted.

Persons interested in presenting a paper at the conference are invited to submit a proposal by October 31, 2020 through the <u>IARIW-ESCoE conference submission portal</u>. Decisions on proposals will be communicated by December 15, 2020. Selected papers from the conference will be published in a supplementary issue of the *Review of Income and Wealth*.

Special IARIW-TNBS Conference on Income, Wealth and Well-being in Africa

The IARIW, in partnership with the Tanzania National Bureau of Statistics announces the conference "Measuring Income, Wealth, and Well-being in Africa" which will take place in Arusha, Tanzania, October 7-9, 2021. This will be the first conference that the IARIW has organized in East Africa.

The main aim of the conference is to bring together academics, statisticians, policymakers, and other data users interested in the measurement of income, wealth, and well-being in an African context. The chair of the Program committee is Lars Osberg from Dalhousie University,
